- Investor can Pause/Unpause SIP at any time, by filling in this form and submitting the same at any POA of Abakkus MF / Kfintech.
- SIP Pause/Unpause facility is available for only Monthly registered SIP.
- SIP Pause/Unpause request must be submitted 15 days in advance from the next SIP due date.
- SIP Pause/Unpause is eligible for SIP's which has completed 6 months of tenure.
- The SIP Pause/Unpause will not be applied for SIP insure and Flexi SIP. For top-up SIP, the top-up frequency would remain unchanged even if there is a pause in SIP instalment. SIP tenure end date will not be extended and subsequent STP / SWP will be rejected if there is no unit balance in the said scheme.
- SIP Pause / Unpause facility will not be available for the SIPs sourced/registered through MFU, Exchange & Channel platforms as the mandate is registered by them.
- In case of multiple SIPs registered in a scheme, SIP Pause/Unpause facility will be made applicable only for those SIP instalments whose SIP date, frequency, amount and Scheme / Plan is specified in the form. If not specified, all SIP's in the scheme will be accepted for pause.
- In case of any discrepancies in the information provided in the SIP Pause/Unpause Form and the details registered with the AMC, the details registered with the AMC shall be considered for processing. In case of ambiguity in the SIP Pause/Unpause Form, AMC reserves the right to reject the SIP Pause/Unpause application.
- Any SIP installment falling within 15 days post receipt of unpause request may not be processed.
